

Public offer on the conclusion of a donation agreement

1. Meaning of this public offer

1.1. The Offer may be amended and supplemented, which come into force from the day following the day of their placement on the Site. The invalidity of one or more terms of the Offer does not entail the invalidity of all other terms of the Offer.

1.5. The place of placement of the Offer and the place of conclusion of the contract is the city of Moscow, Russian Federation.

1.6. This Offer is governed by and construed in accordance with the laws of the Russian Federation.

2. Terms of the Agreement

2.1. Donation Amount: The amount of the donation is determined by the Donor.

2.2. Purpose of donation: CHARITABLE DONATION.

3. Procedure for concluding the Agreement

3.1. The Agreement is concluded by accepting the Offer by the Donor.

3.3. The performance by the Donor of the actions provided for in clause 3.2 of the Offer is considered acceptance of the Offer in accordance with Part 3 of Art. 438 of the Civil Code of the Russian Federation.

3.4. The date of acceptance of the Offer and, accordingly, the date of conclusion of the Agreement is the date of receipt of funds from the Donor to the account of the Recipient.
